In regard to the agenda item "Planning for Telecom Expansion in Seward County", Oliver Borchers Williams and Shaimaa Saydo of SouthEast Nebraska Development District (SENDD) were present to give information about the BEAD Program (Broadband, Equity, Access & Deployment) which involves broadband internet. The Nebraska Broadband office is involved in facilitating the BEAD program. Saydo also gave information about the Digital Equity Capacity grant.

The Commissioners discussed the planned Scrap Tire Event to be held on May 16 & 17, 2025 from 8 a.m. to 12 p.m. at the Seward Road Shop at 3427 Waverly Rd. They discussed the parameters for the event, such as no trailers longer than 14 feet, need to be a Seward County resident, etc. which were the parameters in the last grant offered in the fall of 2024. They decided to change some restrictions for this event such as trailer length, having the event for two days, opening it up to businesses, etc.

Aaron Clark Of NextLink was present to request support for the Nebraska BEAD Defined Project Area that will be impacted by NextLink's projects. He gave information about his company and the projects they have done in years prior. Questions arose about whether or not they would use fixed wireless (towers) or fiber for rural broadband. Jonathan Jank, Executive Director of Seward County Chamber & Development Partnership (SCCDP), added comments to the discussion agreeing that fiber is the preferred method of installation of rural broadband.

He stated he has sent the proposals to the other members of the board and asked them to review and give their feedback. He stated that the bylaws will then be reviewed by the Region V and Apace Boards at their May meeting. Commissioner Ahmic had read the proposed bylaws and there was discussion about her questions.

Marcus Kallhoff, Weed Supt., presented the Nebraska Dept. of Agriculture Weed Report for 2024. He started as the Weed Supt. of Seward County this past year and this is the first report he has submitted. He gave information about the report and his plans for getting a certification and spraying for the next year.
