The Commissioners recessed at 9:28 a.m. The Commissioners reconvened at 9:30 a.m.

Zabrocki led discussion about the courthouse uplighting. Verle Wiemer of Mercer Zimmerman was present to give information about lighting the Seward County Courthouse. He gave a PowerPoint presentation which showed other courthouse-type buildings his company has illuminated. He also provided an example of what could be done for the Seward County Courthouse. The approximate cost is \$192,500. The Commissioners will discuss the project, including costs and funding, at a later date.

The Commissioners discussed installing a handicap actuator at the center door of the West Wing. The entrance has an exterior door, but also has a second door into the interior of the building. They discussed that the actuator needs to open both doors. Building and Grounds Supt., Eric Hofer gave information about the door entrance. Taking the interior door off vs the actuator opening both doors was also mentioned. Hofer will come back with more information at a later date.

He stated this respirator suit would be used when welding to protect the persons from fumes or when personnel are applying chemicals. He stated this was included in a grant application with Nebraska Intergovernmental Risk Management Association (NIRMA) but the portion of the grant which would pay for the respirator suit was not approved. The cost of the suit was quoted at just over \$1,300. It was suggested the Road Dept. budget be used to purchase this suit and also a suit for the Road Dept. employee who sprays chemicals.

#### **Commissioners Reports:**

Commissioner Zabrocki reported he attended the Seward City Council meeting, a Seward City Planning Commission meeting, participated in the Nebraska Intergovernmental Risk Management Association (NIRMA) roundtable via Zoom, met with the Public Transit staff about a driver safety training course, met with the Building & Grounds Supt. about a donation of a bench on the courthouse lawn and checked roads.

Commissioner Schmieding reported he and Commissioner Zabrocki are setting up meetings for employee evaluations, called constituents who had questions about road projects and attended a Region V/Apace meeting the previous day.

Commissioner Ahmic reported she met with Seward County Chamber & Development Partnership (SCCDP) staff related to the Broadband Task Force, took flood plain management classes, completed a zoning inspection, and completed the Safe Streets and Roads grant information.

Commissioner Culver reported he attended Garland Village Board meeting, dealt with emails and checked roads.

Commissioner Hain reported she attended the Goehner Village Board meeting, met with Commissioner Zabrocki and the Seward City Clerk about a possible grant writer position, participated in a Zoom meeting about opioid settlement funds and grants, talked to the Highway Supt. staff about evaluations and grants. She also worked on a flyer for the Community Safety Action Plan and participated in a Zoom about the Wellbeing Initiative. She also met with the Grievance Board.

Sara Stenger of the Detention Center was present to ask the Commissioners to sign a Memorandum of Understanding (MOU) with Wellbeing Initiative Inc. to provide onsite peer support for inmates.

The Commissioners discussed the cancellation fees for gWorks for GIS services. GIS services for Seward County are now being provided by another vendor. Barb Armstead, Deputy County Attorney, had reviewed the contracts of the Road, Weed and County Clerk offices and noted the cancellation fees. She said that going forward, she will ask departments to be more proactive and involved more with their contracts. The cancellation fee for the Road Dept. contract was 35%, but GWorks listed 50%. Barb will contact them and report next week.

Commissioner Culver led discussion on the Secure Tech Systems invoice for panic buttons. The original motion approving the purchase was for less than the invoice received. Culver stated 4 extra panic buttons were requested during installation, thus the extra amount.

Moved by Zabrocki and seconded by Hain to approve the invoice sent by Secure Tech Systems for the panic buttons and reflecting an additional 4 panic buttons at \$139 each, bringing the grand total to \$24,564.00 with funding to be taken from the Inheritance Fund as approved in claims today.

During Legislative update, it was noted that the Inheritance Bill might be discussed today.
