Commissioner Hain discussed the minutes of August 5, 2025. Currently, if a resolution is passed, the wording of the document is typed into the minutes. She stated she does not like that fact that a document is "re-typed" into the minutes. Sherry Schweitzer, County Clerk, stated the document must be put in the minutes somehow and because the document passed by the Commissioners is a pdf, it is the only way for the wording to appear in the minutes.

The Commissioners discussed the storm damage over the weekend of August 9, 2025. Gary Petersen, Emergency Manager, gave information about the process in submitting damage estimates and difficulties with communication with different entities.

An Emergency Declaration was completed by the Chair on August 9, 2025.

Jon Regnier, Highway Supt., and Trever Trebilcock, Asst. Highway Supt., were present to give information about hiring a contractor to help with maintaining roads. Because of short staffing, weather conditions, and major use of the roads, many roads have fallen in bad shape. The Commissioners have asked Regnier to get quotes for hiring an outside contractor for the roads that need work. The list of roads they provided was only a partial list of the roads that need work, so they will compile a complete list, and the Commissioners will discuss it at a future date.

The Commissioners also discussed trees in the right of way. State statute says each landowner shall keep brush and trees trimmed in the right of way/ditch when it becomes a nuisance when traveling on the roads. It has been noticed lately by residents and others that there are trees blocking signs, etc. Regnier and Trebilcock gave information about it and had obtained a quote of around \$250 per hour for a contractor to remove them. Because it is the landowner's responsibility to keep the right of way clear, a letter will be sent out to landowners about their responsibility.

The Senior Equipment Operator item will be discussed next week.

The Commissioners continued discussion about the minutes. Schweitzer said that she has been doing the minutes the same for many years and has received no complaints. Hain didn't realize the minutes were made in this manner.

During the County Official reports item on the agenda, Schweitzer gave information about the damage Seward County had to its buildings and contents. She stated that insurance has been contacted, and quotes are being obtained.

Highway Supt., Jon Regnier updated the Commissioners on activities of his department.

Zoning Administrator, Marissa Pfile updated the Commissioners on activities of her office.

The Commissioners recessed at 10:11 a.m.

The Commissioners re-convened at 10:16 a.m.

The Commissioners discussed the Seward County 2025-2026 budget. The jail budget was the first discussed with new Jail Administrator, Sara Stenger. Andrew Treslow, Assistant Jail Administrator, and Sheriff Vance were also present.

The next budget the Commissioners discussed was the Sheriff's budget. Sheriff Vance and Captain Melby were in attendance to discuss the budget.

The Commissioners recessed at 11:31 a.m.

The Commissioners re-convened at 11:33 a.m.

The next budget that was discussed was for the Zoning Administrator. Marissa Pfile, Zoning Administrator, was in attendance.

The Commissioners discussed the total budget and what the levy would be with setting the tax request at different amounts.

## **Commissioners Reports:**

Commissioner Pekarek reported he spent time at the Sheriff's Office learning about their Drug Interdiction funding. He also received a comment about the flagpole on the courthouse.

Commissioner Schmieding reported he has Visitors' Committee and Blue Valley Community Action (BVCA) meetings in the near future.

Commissioner Ahmic reported she dealt with the Public Service Committee on a charge on telephone bills, attended a Broadband Task Force Meeting and a meeting with Seward County Chamber & Development Partnership (SCCDP). She also received a call about issues about a fence and dam, received a comment about a truck route for Commercial Animal Feeding Operation (CAFO), worked on the budget and also on the storm damage, had a meeting with the representatives of the Sheriff's Dept. and Commissioner Hain. She also attended the Milford City Council meeting.

Commissioner Zabrocki reported he participated in a Nebraska Intergovernmental Risk Management Assn. (NIRMA) roundtable Zoom meeting, attended the Broadband Task Force meeting, met with Commissioner Ahmic about the budget, and received many comments about the recent storm.

Commissioner Hain reported she received multiple notifications about money being received from the opioid settlements, checked roads, received comments about a future Conditional Use Permit, assisted with a lot of storm damage clean up, received comments from various representatives about having a place for residents to go due to problems with the storm, discussed a process that is possibly needed when the Emergency Manager is gone, talked to a school representative about law enforcement in the schools, and will have a meeting with a County Attorney's Office about the juvenile plan. She contacted the Road Dept. about storm damage and met with Commissioner Ahmic and representatives of the Sheriff Dept.
