Moved by Pekarek and seconded by Ahmic to reopen the discussion of approving the Equitable Sharing Agreement and Certification of the Sheriff's Office.

Commissioner Pekarek started discussion on the need to approve of the Equitable Sharing Agreement & Certification (ESAC). He stated there are costs that the Equitable Sharing Funds have paid for and if this agreement is not approved, we would not be in compliance and would not receive any funds from the federal government. He said the county would need to budget more to help pay for things that previously were paid by the Drug Funds. Commissioner Ahmic said the Sheriff's General budget has already been agreed to with Sheriff Vance. There were concerns about some of the statements/information on the ESAC.

Commissioner Hain read a letter referencing the work she has done in regard to the Treasury Equitable Sharing Funds more commonly known as the Drug Funds from the Treasury Dept. She cited multiple letters received by the Sheriff's Office & sent from the Department of Treasury in which there were impermissible expenditures by the Seward County Sheriff's Office per the Guide to Equitable Sharing for State, Local, & Tribal Law Enforcement Agencies. Even though the letter was acknowledged and received by the Sheriff's office shortly thereafter, the Sheriff's Office continued to submit expenses to be paid. One letter discussed how an annual report called the Equitable Sharing Program Agreement & Certification (ESAC) should be modified to account for errors. She stated she did not think the ESAC could be signed at this time and should be tabled until more information is obtained.

Armstead gave information about what the Commissioners would approve if they signed the agreement and certification. All Commissioners made comments about the ability to sign or not to sign the ESAC.

Moved by Pekarek to authorize the Chair to sign the Equitable Sharing Agreement and Certification.

Motion died for lack of a second.

After lengthy discussion, the Commissioners decided not to sign the Equitable Sharing Agreement and Certification at this time until the requests from the federal government are resolved.

Moved by Hain to table signing of the Equitable Sharing Agreement & Certification until Feb. 3 2025 and make recommendations for compliance moving forward.

Motion died for lack of a second.

It was decided that Commissioners Pekarek and Hain meet with Sheriff Vance and his staff to be able to come up with answers to the problems the federal government has outlined in communication.

The Commissioners then discussed the "Set the Numbers of Deputies for the Seward County Sheriff's Dept." item on the agenda.
