Commissioner Vrbka reported he attended the NACO conference and received various questions from constituents.

Commissioner Culver reported he attended the NACO Conference, dealt with Blue Valley Community Action mandates, will attend a 911 meeting this evening and worked on ARPA items.

Commissioner Schmieding reported he attended the NACO meeting and talked to Southeast Nebraska Development District representatives.

Commissioner Zabrocki reported he attended the NACO conference, was helping at the 911 Center and will attend a 911 meeting tonight.

Ann Dobesh, Extension Educator, presented two applications from individuals who wish to volunteer to be on the Extension Board.

The Commissioners re-convened at 9:30 a.m.

Matt Starkey, Veteran Services Officer, was present to give information about a part time employee for the Veteran Service Office. He gave information about the veteran population in Seward County and the work that he would like the employee to help with.

Moved by Ahmic to approve the request for a part time Veteran Services Officer's Assistant.

The Commissioners discussed a wage for the new Veteran Services Officer's Assistant.

Moved by Zabrocki and seconded by Ahmic to approve the wage for the part time Veteran Services Officer's Assistant at \$15.60 per hour.

The Commissioners discussed setting salaries for the elected officials who are up for election for the years 2023-2026. Chairman Culver led discussion and gave information for his suggestion.

Moved by Zabrocki and seconded by Ahmic to adopt Resolution No. 3562 in regard to setting the salaries for the Seward County elected officials for the years 2023-2026.

RESOLUTION NO. 3562 OF THE SEWARD COUNTY BOARD OF COMMISSIONERS

WHEREAS, the laws of the State of Nebraska provide that the salaries of elected officials be fixed by the County Board prior to January 15, of the year in which a general election will be held for the respective offices; and

WHEREAS, all elected county officials shall be included on an equal basis with other County Employees as to the provisions and benefits of any group insurance, retirement, life insurance or any other benefits adopted by the County Board of Commissioners; and

WHEREAS, salary increases to accommodate cost of living increases should be granted such elected officials on an annual basis.

WHEREAS, the Nebraska Association of County Officials completed a salary study and published "2023-2026 Salary Recommendations for County Officials" in October of 2021; and

WHEREAS, said salary study set a minimum base salary of elected officials, in Seward County, to be between \$69,400 and \$91,400 for the year of 2023 with annual increases for the years 2024, 2025, and 2026; and

WHEREAS, said salary study states that the minimum base salary recommendation should be the least amount acceptable to provide a livable income for a person maintaining the duties of the county office; and

WHEREAS, said salary study set the Attorney minimum salary to be 160 % of the minimum base salary, Sheriff minimum salary to be 125% - 140% of the minimum base salary, and County Commissioner minimum salary to be 50% of the minimum base salary.

NOW, THEREFORE, BE IT RESOLVED, by the Seward County Board of Commissioners, that the following salaries for the respective offices be established for the term of office encompassing the calendar years of 2023, 2024, 2025, and 2026 for all elected officials who are subject to election in 2022 and being sworn into office in 2023; and 2023 and 2024 for the County Commissioners office.

The annual salary of the office of County Commissioner is hereby established at 43% of the County Assessor, Clerk, Treasurer, and Clerk of the District Court salary for the calendar years of 2023 and 2024.

The annual salary of the office of Attorney is hereby established at 160% of the County Assessor, Clerk, Treasurer, and Clerk of the District Court salary for the calendar years of 2023, 2024, 2025, and 2026. The County Attorney shall devote his or her full time to the legal work of the office of the County Attorney and shall not engage in the private practice of law.

The annual salary of the office of Sheriff is hereby established at 140% of the County Assessor, Clerk, Treasurer, and Clerk of the District Court salary for the calendar years of 2023, 2024, 2025, and 2026.

The annual salary of the office of County Assessor, Clerk, Treasurer, and Clerk of the District Court is hereby established at \$82,000.00 for the calendar year 2023; \$84,500.00 for the calendar year of 2024; \$87,000.00 for the calendar year 2025; and \$89,500.00 for the calendar year 2026.

The County Surveyor salary shall be \$10,000.00 during the calendar years 2023, 2024, 2025, and 2026.

FURTHER, all elected county officials shall be included on an equal basis with other County Employees as to the provisions and benefits of any group insurance, retirement, life insurance or any other benefits adopted by the County Board of Commissioners.

BE IT FURTHER RESOLVED that in the event the County Board should designate any elected official, who is a qualified individual or who is provided for designation by statute, to serve as the Budget Making Authority, he or she shall, beginning in the calendar year 2023 and ending in the calendar year 2026, receive \$10,000.00 for each calendar year that said official is designated as the Budget Making Authority.
