Commissioner Reports:

Commissioner Pekarek reported he attended a meeting featuring Senator Hughes at the library, met with the Human Resources Director, Commissioner Ahmic & a representative from the county's health insurance company, met with Commissioner Hain, met with Commissioner Ahmic, contacted the Garland Village Clerk & Board Chairman, registered for the upcoming Nebraska Association of County Officials (NACO) conference, and assessed some culvert projects with Commissioner Hain.

Commissioner Schmieding reported that two of his scheduled meetings were canceled due to weather, he attended an Extension Board meeting, met with the Building & Grounds Superintendent, and drove some of the county roads.

Commissioner Ahmic reported she had a call with Broadband Task Force members, met with the Highway Superintendent & Assistant Highway Superintendent, received calls about the 1 & 6 Year Road Plan, had a call with a local Housing and Urban Development contact, talked to Commissioner Schmieding about joining the Blue Valley

Community Action Board in her place, was asked by the Solid Waste Management Board to check with the other Commissioners about the county's interest in hosting another clean-up day or tire event, attended a Seward County Chamber & Development Partnership (SCCDP) meeting, watched the Legislature for updates, met with the Human Resources, met with three Planning Commission members, attended a Planning Commission meeting, went to Kearney to give presentation at the Highway Safety Conference hosted by the Department of Transportation, spoke with BNSF about railroad ties, met with Commissioner Pekarek & the Human Resources Director about health insurance, did research regarding the landfill, and received phone calls regarding roads.

Commissioners Zabrocki had a Nebraska Intergovernmental Risk Management Association (NIRMA) teleconference, contacted a constituent regarding the board's decision on paying a tow bill from last week's meeting, attended a Planning Commission meeting, had a meeting with Human Resources and reported on an accident involving a Public Transit vehicle.

Ray Foreman, Veterans Service Officer, introduced the February 2025 Veteran of the Month, Dave Pankoke.

Pankoke was drafted into the service after graduating from the Automotive Department at the school in Milford. While in the service, he performed maintenance on heavy equipment. Pankoke is active in the American Legion and serves on the Veterans Service Committee.

Commissioner Reports, continued:

Commissioner Hain reported she provided written testimony on multiple bills in the Legislature, attended an Extension Board meeting, received a call about a tax sale issue, spoke to County Treasurer and County Attorney about that issue, spent time reviewing the Interlocal Agreement with the Four Corners Health Department, spoke with the Highway Superintendent regarding road conditions, received an email from Kirkham Michael, had a Teams meeting with the Highway Superintendent and officials from the City of Seward, met with several department heads, met with a representative from the Nebraska Department of Transportation Infrastructure Hub, met with a representative from Onyx Overlay with the Highway Superintendent & Assistant Highway Superintendent regarding asphalt roads, met with Commissioners Pekarek to assess projects on the 1 & 6 Year Road Plan, and met with the Juvenile Comprehensive Plan team.

Moved by Zabrocki and seconded by Hain to open the public hearing on the proposed 1 & 6 Year Seward County Highway Department at 9:33 a.m.

Jon Regnier, Highway Superintendent & Trever Trebilcock, Assistant Highway Superintendent, were present to answer questions during the discussion.

Regnier led discussion regarding repairs and future plans for the portion of Fairground Road between Hillcrest Drive and Lincoln Street. His department recently met with representatives from the City of Seward to discuss this matter. This road, which is not within the city limits, is in poor condition. The county will be putting concrete on this

road in a small area that is in the worst condition, but something more needs to be done with the entire stretch of road. There were questions regarding whether the city plans to annex the road into the city limits. Mike Oneby, City Engineer, stated that traditionally, the city requires that a developer pay for the infrastructure up to all of the city's standards, and everything in the right of way then becomes dedicated to the city. Because of that, if the city annexed it, they'd prefer that it meet or be very close to meeting city standards at that time. As this road is not part of the city's 1 & 6 Year Road Plan, there wouldn't be a plan to repair it for at least the next 7 years, and currently there has been no discussion to advance this road above other priorities. Oneby stated that Greg Butcher, the City Administrator, suggested that the Commissioners and Seward City Council need to converse on developing a plan to resolve the current issues. A team of representatives from both will be established to begin developing a plan.

Laura McDougall, Executive Director of Four Corners Heath Department, was present to update the Commissioners on their department's activities.

Next, McDougall discussed appointing a physician member to the Four Corners Health District Board for the term of 2025 to 2027. Dr. Jillian Fickenscher is the current board physician and she has volunteered to continue serving. Commissioners Ahmic and Hain asked questions regarding the availability of this position being shared publicly to allow others an opportunity to serve if interested.

Moved by Hain and seconded by Zabrocki to appoint Dr. Jillian Fickenscher as the physician member on the Four Corners Health District Board for the term of 2025 to 2027.

The Commissioners recessed at 10:41 a.m. The Commissioners reconvened at 10:46 a.m.

Wendy Elston, Seward County Attorney, Brandon Noordhoek, Detention Center Director and Lisa Borges, Sheriff's Office Administrative Captain, were present to discuss the exceptional anticipated costs associated with Seward County Court Case CR25-55. Elston stated this is for a murder case, which is generally not budgeted for within normal office budgets. Expected expenses could include mental health evaluations, depositions, expert witnesses, etc., and could become very costly to the county. Noordhoek reported that Seward County took this individual into custody on February 14th. Detention Center staff have been providing 24 hour/day security in the medical facility where the individual is still currently receiving care. Borges stated that the Sheriff looked into private security, but it's much more cost effective for the county to have corrections staff there than it would be to hire private security. Zabrocki asked if the county will be responsible for paying for medical care prior to Seward County taking custody of the individual. Elston stated that the county is not responsible for costs incurred prior to the individual being in the county's custody. Statutes provide that the hospitals are under obligation to seek private insurance first. Although Elston anticipates a large majority of legal costs will occur during the next fiscal year budget, there will be costs related to staffing and security during this fiscal year. Currently, there is \$100,000.00 budgeted in the Inheritance Fund to cover potential legal fees and/or major trials. Those funds can be used to cover expenses incurred during this fiscal year, and additional funds will be budgeted next fiscal year to cover the costs associated with this case.

Zabrocki led discussion on the courthouse maintenance project with Berggren and Associates. The project includes power washing and tuckpointing the exterior of the courthouse, as well as replacing the handrails outside the courthouse. The project would need to be re-bid, as the current estimate is over a year old. Discussion was held regarding the current potential expenses the county will be incurring due to the previously discussed court case, posing the question of whether this is something to pursue at this time. It could potentially save money if the Building & Grounds Superintendent could lead this project himself. Schmieding stated he is in favor of the project, but he is not in favor of hiring extra people to oversee it. Zabrocki will contact

Berggren & Associates to let them know their services won't be needed for this project. The handrail replacement is a much lower cost than the other projects and could potentially be paid using the Commissioners Sinking Fund. This will be added to next week's agenda after the Sinking Fund balance is verified with the Clerk's Office.

Ahmic led discussion on department closing policies & procedures. Recently, there have been instances of departments closing when the rest of the county does not close due to weather. Ahmic asked Barb Armstead, Deputy County Attorney, to look into the current policy regarding offices closing. The current policy relating to county offices closing due to weather was also discussed. Pekarek stated that he was not in favor of the most recent weather closure decision. The policy for closing will be reviewed.

Commissioner Schmieding is absent at 11:13 a.m.

Hain led discussion on the estimate from Middle Creek Printing for Seward County vehicle decals. She asked Commissioners who are liaisons to departments with county vehicles to visit with those departments to make sure they are purchasing new decals out of their budgets when new vehicles are purchased. She recommended they be purchased through Middle Creek Printing moving forward, as they have the logos on file already.

Moved by Pekarek and seconded by Zabrocki to approve the estimate from Middle Creek Printing in the amount of \$416.50 for vehicle decals, to be paid out of American Rescue Plan Act (ARPA) funds.
