NOW THEREFORE BE IT RESOLVED that the salary for Seward County Commissioners be established for the terms of office beginning in 2025 and 2026 as follows:

Seward County Commissioner's annual salary for the term beginning January 9, 2025, is hereby established at \$36,335.00.

Seward County Commissioner's annual salary for the term beginning January 8, 2026 is hereby established at \$37,410.00.

BE IT FURTHER RESOLVED that during the terms of office listed above, all county commissioners shall be included on an equal basis with other county employees as to the provisions and benefits of any group insurance, retirement, life insurance or any other benefits adopted by the County Board of Commissioners. If changes to health insurance, life insurance, retirement, or any other county employee benefit occur during the above terms of office, county commissioners enrolled in those benefits will be subject to the same modifications.
