He also checked roads and stated Region V meeting will be in the near future.

Commissioner Zabrocki reported he attended the SouthEast Nebraska Development District (SENDD) Board meeting, the Nebraska Public Agency Investment Trust (NPAIT) meeting, the 911 meeting, the Nebraska Intergovernmental Risk Management Association (NIRMA) meeting, a meeting with the Highway Supt., and reviewed legislative bills.

The Commissioners discussed having a consent agenda on the regular agenda of the Board of Commissioners. They discussed which items could be on the consent agenda. Suggestions of items to put on the consent agenda were fee reports and approval of the minutes. There were differing opinions on placing claims on the consent agenda. There were questions also about approving the agenda. The Attorney's Office will look into it.

Sara Stenger of the Justice Center and Tim Huntington of the Sheriff's Office were present to ask the Board to authorize the use of the funds for Anger Management classes in the jail. It would be a voluntary option for an inmate. The previous Detention Center Director had started the process of an MOU agreement with Four Corners Health Dept. for the classes but had not finished the project before she left employment.

Moved by Culver and seconded by Zabrocki to authorize funds to be used for Anger Management Classes within the jail and the costs to be paid out of the Commissary Fund.

Jon Regnier, Highway Supt., was present to talk about the cost of funding options for a mitigation site for Project BRO-7748(1) Beaver Crossing South Bridge on Pioneers Road. He stated that the project directs Seward County to purchase Wetlands Mitigation Credits in the amount of \$110,360.00. He said that the money would be returned as payment for the Federal Fund Project.

Moved by Zabrocki and seconded by Hain to approve the cost of funding for a mitigation site for Project BRO-7748(1) Beaver Crossing South Bridge on Pioneers Road in the amount of \$110,360.00 with the funding to be taken out of the Inheritance and when the funds are reimbursed, is to be put back in the Inheritance Fund.

Regnier also gave information on updating Road Department radios. The idea of trying to save costs last year during budget discussion was to use the radios in the equipment

instead of issuing reimbursement for employees using their personal cellphone. It was discovered that the radios in the Road Dept. equipment were old and ineffective. Quotes from Shaffer Communications, Inc. for new radios and the fee to be on the state system were provided and were more costly than providing cell phone reimbursements. Discussion about county wide communication coverage was discussed. One of the quotes for updating the tower at the Missile Base Shop was also discussed.

Moved by Hain and seconded by Zabrocki to approve the quote from Shaffer Communications, Inc. to upgrade the base of the tower at the Missile Base Shop in the amount of \$11,319.44 to be paid out of the Inheritance Fund and begin cell phone reimbursement for Road Dept. employees in the amount of \$35.00 effective 1/30/2024. Affirmative Vote: Hain, Zabrocki, Schmieding, Culver, Ahmic Motion Carried

The Board then discussed the agenda item of Clarification of the Role of the Board of Adjustment. The Board of Adjustment has not convened for many years in Seward County until recently, it convened and there are questions if the subject matter should have been sent to this Board, but rather appealed to District Court. Jeff Ray, Senior Planner of JEO Consulting, and Becky Paulsen, Zoning Administrator, were in attendance to help with the discussion. Ray, who has been involved with planning for over 30 years, stated that in most cases, there are two types of applications for the Board of Adjustment. The first one is administrative. An example would be if there is a clerical error. The second type is "interpretation" of zoning regulations. For instance, a building now known as a "shouse"- is it a house or an agriculture building? Ray stated that something like that would go the Board of Adjustment if there were a conflict in interpretation of the zoning regulations. He said statutes are clear that the Board of Adjustment does not get involved in certain instances of zoning action such as a conditional use permit. Paulsen said that since the Board of Adjustment convened recently, she has received phone calls from parties asking if they can appeal a Board of Commissioners decision by going to the Board of Adjustment. Ahmic gave information from the handbook of the Nebraska Planning Association. Barb Armstead, Deputy County Attorney, said she has done a thorough investigation and gave a legal opinion on the matter. She stated it was correct that the subject matter came before the Board of Adjustment and was handled correctly. It was suggested that a 2nd legal opinion should be sought. Sharon Powell, Village of Utica Trustee, spoke and felt that her village has encountered the same problem and wants to make sure the village is doing it correctly. Mr. Ray suggested that he and Armstead discuss the issue to see why they differ in opinion. The item will be discussed again at a later date.

Commissioner Zabrocki is absent at 12:12 p.m.

Commissioner Hain led discussion on the Grant Funds being sought by Seward County item on the agenda and stated the Big Blue Tomorrow meeting that was held in Staplehurst last week had great participation. Good response involving letters of support have been received. The Safe Streets and Roads Grant WebEx between the State Dept. of Transportation and Nebraska Association of County Officials (NACO) was mentioned. Information from the Community Projects Fund (CPF) and federal appropriation for a grant was also mentioned.

During the Legislative Update item on the agenda, Commissioner Ahmic shared the NACO list of legislative bills. Many bills were discussed such as LB 1067 in which there is Legislation to eliminate the Inheritance Tax.

The Executive Session was not held.

The Commissioners recessed at 12:56 p.m. as they traveled to the jail for their quarterly jail inspection.

The Commissioners re-convened at 1:11 p.m. at the Seward County Detention Center and inspected the jail.

Commissioner Schmieding was absent at 1:11 p.m.
