Moved by Zabrocki and seconded by Hain to make no change based on the Assessor's recommendation and generally accepted mass appraisal techniques were used to arrive at the value of \$107,176 for property owned by Kelly Naber and described as Lot 10, Block 16, Original Town, Utica, NE.

Commissioner Schmieding reported he will have a Visitors meeting later this afternoon. He also attended the Tree Board meeting the past week.

Commissioner Ahmic reported she participated in a Zoom meeting with Felsburg Holt & Ullevig Consulting firm (FHU), attended the Gage County Board meeting in regard to a grant writer position, talked to the Highway Supt. about ROW permits, worked with the Seward County Fire District on a grant, worked on the county budget, attended the housing meeting and the Planning Commission meeting.

Commissioner Culver reported he attended the Local Emergency Planning Committee (LEPC) meeting and visited with the District and County Court Clerks.

Commissioner Hain reported she met with the Highway Supt. and staff in regard to repairs for the abandoned cemeteries and a grant application, participated in the Zoom call with FHU, attended the Gage County Board meeting, checked roads, spoke with the BRIDGES representative about a Juvenile Justice Plan, and attended the Ag Society meeting.

Jason Strohbehn representing Gravel Worlds spoke about two cycling events that will happen in Seward County on August 24 and 25th.

He gave information on the routes that will be used for each event. The Commissioners stressed that safety is the priority but they welcome events in Seward County.

Tom Nielsen of Soarin' Group was present to discuss the management of technology at the Extension Office. Previously, the internet was changed from UNL internet to the provider of the Seward County internet. Now, they are questioning the management of technology for

the Extension Office equipment. He stated that he spoke with UNL about the ownership of the Extension Office equipment and found out some counties do have UNL maintain their equipment, some counties have the county maintain it. Recently, the Extension Office purchased two iPads through the University. UNL is requesting the county pay for them, but the University wants to have ownership of them. The question is who should pay for the equipment, who should own it and who should maintain the equipment. Nielsen said that UNL may need to own any computer device in order to use their network and resources. Nielsen will contact UNL to find out more information.
