A regular meeting of the Seward County Board of Commissioners was convened in open and public session at 8:30 a.m. on June 2, 2020 in the Commissioner's room at the Seward County Courthouse. Notice of the meeting was posted on the Courthouse bulletin board and on the Commissioner's Room door. The agenda for all meetings is kept continually current and is available for public inspection at the County Clerk's Office during normal business hours. The agenda is held open until one business day prior to the meeting for appearance before the Board. The Board of Commissioners has the right to modify the agenda to include items of an emergency nature only at such public meeting.

The Seward County Board of Commissioners convened on June 2,2020 at 8:30 a.m.

The Chairperson noted that the public meeting information is posted as required by law and available for public distribution if requested.

The Pledge of Allegiance was recited.

Those officials reporting to the Commissioners during the first meeting of the month were Jeff Baker, Ann Dobesh, Marilyn Hladky, Barb Liska and Sherry Schweitzer.

Jonathan Jank, Executive Director of the Seward County Chamber & Development Partnership, updated the Commissioners on activities of his organization.

Moved by Schmieding and seconded by Vrbka to approve the minutes of May 26, 2020. Affirmative Vote: Schmieding, Vrbka, Mundhenke, Paulsen, Culver Motion Carried

Commissioners Reports:

Commissioner Mundhenke reported he checked roads.

Commissioner Vrbka reported he has been working on recruiting additional members for the Planning & Zoning Commission and reported about the County Fair.

Commissioner Culver reported he worked with the County Surveyor, Ron Nissen, on a project; participated in zoom meetings in regard to the coronavirus situation; and received calls on various road issues.

Commissioner Paulsen reported she received some calls in regard to nails found on the roads used by companies to mark utility lines.

Commissioner Schmieding reported he attended a virtual meeting with SENDD and checked some roads.

In regard to discussion on the coronavirus situation with the county buildings, Chairman Culver reported that the county buildings were opened up yesterday according to plan. He stated that although there were a few problems, most generally things went well.

Brea Ehmen, HR Director, presented a change for Holiday Pay in the Personnel Policy to the Commissioners for their consideration. She said the past policy stated Holiday Pay should be given to those working on the "observed" holiday. The change would make it so holiday pay would be given to those working on the actual holiday.

Moved by Mundhenke and seconded by Paulsen to make the following change of the Holiday Pay into the Personnel Policy as follows:

HOLIDAY PAY

Each full-time employee, who is not required to be on duty, as their respective office is closed, will be allowed to be absent from work without loss of pay on a holiday, provided that such employee shall not be absent without approved paid leave on either the day prior to or the day after such holiday in order to qualify for said holiday pay.

Full-Time employees who do not actually work on a holiday shall receive eight hours of holiday pay only and said hours shall not be used in the accumulation of hours worked for overtime purposes.

Regular Part-time, 30 hour/week employees will be eligible for 6 hours of holiday pay, following the same criteria above.

Premium Holiday Pay

Non-exempt county employees who work on a declared holiday shall receive monetary payment at the rate of two and one-half (2 ½) times the employee's normal hourly rate for such hours actually worked on said holiday. No additional compensation shall be made for those hours worked. The employee shall be paid for said holiday hours worked and not applied to compensatory time. Holiday hours actually worked shall not be used in accumulation of hours worked for overtime purposes. All work on declared or observed holidays must be approved by the employee's supervisor.

Observed Holiday

If one of the above declared holidays falls on Sunday, it will be observed by offices who are normally closed on weekends, on the following Monday. If the declared holiday falls on a Saturday, it will be observed by offices who are closed on weekends, on the preceding Friday.

24-hour schedule employees

Departments that operate a 24-hour schedule will recognize the declared holiday with regards to premium holiday pay on the "declared" holiday. The premium holiday pay of 2 ½ times will not apply to 24-hour schedule employees working on the "observed" holiday. The 24-hour schedule employee that does not work on the declared holiday shall only receive 8 hours of holiday pay. Should an employee work the observed holiday and the declared holiday, the employee will be compensated for normal worked hours on the observed holiday and shall receive the premium holiday pay of 2 ½ times all hours worked on the declared holiday.

The premium pay of 2 $\frac{1}{2}$ times includes the aforementioned 8 hours of regular holiday pay and will not result in an additional 8 hours of regular holiday pay.
