Commissioner Mundhenke reported there was a lot of tree damage in Milford and checked roads.

Commissioner Vrbka reported he checked roads by Milford.

Commissioner Culver reported he received damage from the storm and checked roads. He also stated he participated in several conference calls, preparing for evaluations of appointed individuals.

Commissioner Paulsen reported she had a meeting with the City of Seward at the Road Dept. and worked on various correspondences.

Commissioner Schmieding reported he attended a Region V meeting and a SENDD meeting.

Moved by Vrbka and seconded by Mundhenke to appoint Dale Niemann to the Planning & Zoning Board.

The Commissioners discussed opening county facilities that were closed previously due to the coronavirus situation. It was reported that last Wednesday, the driver license examiners were here and although there was a line, things went well. Other nearby county facilities are not open yet, so the Treasurer's Office is anticipating being busy on Wednesdays in the near future until other facilities are open.

Chairman Culver suggested opening all doors of the Courthouse next Monday, June 15, 2020. He stated there are presently only 4 active cases of Covid 19 in Seward County so he feels opening to the public is a possibility. The Commissioners will ask each office to make a list of visitors to their office and will ask the Sheriff's posse to help for the month of June. All doors will be open as well as the public restrooms.

Moved by Schmieding and seconded by Mundhenke that the Seward County facilities be fully open to the public effective June 15, 2020 and each office log a list of those that come into their office.

Maria Hatfield, Justice Center Director, was present to discuss the Accurate Service Contract for the Justice Center. She stated that in January 2022, the current contract will end and a new contract will need to be entered into at around \$65,000 for 3 years. She stated that it is for the whole Justice Center, not just the Jail portion, and thought the Commissioners should know about it so they can plan and budget for it.

The Commissioners discussed the location of the Farmers Market. Gary Rolf was present and participates in Farmers Market. The Farmers Market is usually on the courthouse square but due to the coronavirus and social distancing, Farmers Market is now at the parking lot of a local grocery store. He asked if, after the current coronavirus situation, the Commissioners would endorse the idea of the coming back to the Courthouse area. Commissioner Paulsen said it has been suggested that Farmers Market be on the street to the East of the courthouse building. She stated it would save the grass and would alleviate congestion. Eric Hofer, Building and Grounds Supt., endorsed the idea of having Farmers Market in the street. Clark Kolterman also spoke on the issue and said the current space is not working out and stated the courthouse square is the best place. No action was taken.
