### **Commissioners Reports:**

Commissioner Schmieding reported he attended the open house at the newly renovated Civic Center and a meeting of the Extension Office. He will have a Visitors Committee meeting later today and this evening he will attend a Blue Valley Community Action (BVCA) meeting.

Commissioner Ahmic reported she attended the Seward County Planning Commission meeting, spoke to the Public Defender, received calls about roads, gave information about a grant, looked into Defensive Driving training classes and reviewed some budgets and expenses.

Commissioner Zabrocki reported he attended the formal announcement of a candidate for Legislature, attended the Region V and Apace meeting, asked to secure a nomination for the Seward County Veterans Service Committee and checked abandoned cemeteries. He will attend the Seward City Council meeting tonight.

Commissioner Hain reported that she talked to Human Resources about training for defensive driving, participated in a Zoom meeting with Four Corners Health Dept. and a Four Corners Health Dept. Finance Committee. She attended an Extension Board meeting, reviewed grant information, and attended the Flag Burning ceremony at the courthouse. She also gave a presentation at the Utica Senior Center and attended the Ag Society meeting.

Carrie Rodriguez, Chief Probation Officer of the 5<sup>th</sup> Judicial District, was present to give information about probation services in Seward County and give the request for the next fiscal year which was \$36,216.78.

Jon Regnier, Highway Supt., was present to discuss the possible vacation of 182<sup>nd</sup> Road between Agnew Road and Little Salt Road, which is currently a minimum maintenance road. Currently there are residents that live on the road, and they need access with a reliable road. It was suggested that the residents be given an easement in order to use that portion as their driveway. The other half of the road will be vacated. Neighboring landowners are agreeable to this suggestion. Regnier will start the process of vacating the road.

Regnier was also present when the right of way work being completed by Charter Communications agenda item was discussed. Commissioner Ahmic showed pictures of installation of fiber that were unsatisfactory. Property was left in bad shape with tire tracks and dirt piles left. Regnier will talk to them and no permits will be approved until they fix the installation of fiber in question.

Barb Armstead, Deputy County Attorney, led discussion on the Johnson Dam Road project. At the request of a landowner, it was discovered a road going through their property had changed throughout the years. The County Surveyor surveyed the old road and also the new road (that has changed over the years). The suggestion is the county would deed the old road to the property owner and the property owner would deed the new road to the county. She said she started to prepare a deed and was not sure of the legal description. The County Clerk will look into her records to see about ownership and report back.

Marissa Pfile, Zoning Administrator, was present when clarifying the name of Specific Conditions of Findings of Facts document attached to Resolution No. 3846 approved on May 20, 2025.

Moved by Hain and seconded by Zabrocki that we clarify the name of Specific Conditions of Findings of Facts document attached to Resolution No. 3846 approved on May 20, 2025 and that we replace the name of Gordon Luebbe to Luebbe Family Poultry, LLC.

Pfile was present during the agenda item "Addressing for 923 280<sup>th</sup> Road." She stated the postmaster for that area has asked for assistance since there is a mail delivery problem. There are two addresses at this address with one address having an additional "Lot 30". Alan and Carolyn Kortmeyer were present to say the address was established in 1977 and their address at that time was Rt. 2 Box 237. When Seward County changed to 911 addressing, the owner of their Glenhaven Village Mobile Home Court worked with Seward County and established 923 280<sup>th</sup> as the address and each resident in the court was to use their lot number. Her number was Lot 30. Since then,

they have re-platted, and they have still used the same address. She stated she has been given this address for 35 years. A KOA Campground has now been built next to the Kortmeyers and both use the same lane to get into their property.

Alyssa Hendrix, owner of the KOA was also present to give information about her business and the address she is having problems with. She stated she has rented a post office box since opening her business. Seward County assigns numbers for addressing but these mailboxes are along a state highway, so the state is involved also. After discussion, it was suggested that Pfile call the state to see if Hendrix can place a mailbox at the entry along with Kortmeyer's mailbox.

Pfile was present when the Commissioners considered a part time Zoning Office Assistant job description approved. Roxanne Knutson, Human Resources Director, gave information about the job description. Pfile gave examples of what this part time position would do. The Commissioners discussed starting the position at 20 hours and if more time is needed, address that later.

Moved by Hain and seconded by Zabrocki to approve the request for a part-time Zoning Office Assistant and the job description not to exceed 40 hours a pay period.

The Commissioners recessed at 10:37 a.m. The Commissioners reconvened at 10:43

Sheriff Mike Vance and Captain Brad Melby were present to discuss the "Law Enforcement Budgets and the Number of Deputies Authorized by the County Board and Equitable Sharing Replacement Officers" item on the budget. The two Sheriff Interdiction Funds are almost depleted, and another "drop" of money is not guaranteed in time for the new Fiscal year, so the Commissioners were inquiring how to pay for future costs that are normally paid from these funds. Vance said he has contacted the Department of Justice (DOJ), and he was told funds would be coming. He said it was "in disbursement". Commissioners asked Vance what his plans are if DOJ funds are not received in time for the next claims and Vance replied he would ask that all salaries be taken out of his General Fund. The Commissioners continued to ask questions about the expenditures of the current fiscal year, how many officers are in his department and what to do about the salaries for the next claims period. Discussion will continue next week to see if funds are received and what the next steps will be.
