RESOLUTION #3810 OF THE SEWARD COUNTY BOARD OF COMMISSIONERS

WHEREAS, a proposed County Budget for the Fiscal Year July 1, 2023 to June 30, 2024 as prepared by Sherry Schweitzer, Budget Making Authority, was adopted on September 26, 2023 by Resolution # 3781, and

WHEREAS the Seward County Board of Commissioners desire to amend the budget due to insufficient funds in Fund 2412 – Sheriff Federal Drug Law Enforcement Fund – Treasury. No additional tax monies are needed.

NOW, THEREFORE BE IT RESOLVED,

by the Board of Commissioners of Seward, County, Nebraska as follows:

SECTION 1. That the budget for the Fiscal Year July 1, 2023 to June 30, 2024, as categorically evidenced by the Budget Document be, and the same hereby is amended as the Budget for Seward County for said fiscal year.

SECTION 2. That the offices, departments, activities and institutions herein named are hereby authorized to expend the amounts herein appropriated to them during the fiscal year beginning July 1, 2023 and ending June 30, 2024.

SECTION 3. That the income necessary to finance the appropriations made and expenditures authorized shall be provided out of the unencumbered cash balance in each fund, revenues other than taxation to be collected during the fiscal year in each fund, and tax levy requirements for each fund.

She stated she received a comment from a constituent about a USDA grant involving composting and will forward that information to the Extension Office.
