Starkey was present to discuss the "Reorganization of the Public Transit/Veteran's Service Departments item on the agenda. Currently, his position is Director of the Veteran's Service and Public Transit. Starkey led discussion that he believes the Public Transit Department Director needs to be Full time and not part of the Veterans Service Department. He said he believes the operation of the Public Transit Dept. warrants full time and the Veterans Service Officer position could be part time. Commissioner Ahmic stated that she has talked with Starkey on the issue and said that many times, Veterans are not able to see Starkey due to Public Transit demands. Starkey stated that in 2020 - 2021 the average was approximately 800-1,000 rides per month and now it is at an average of 1200 rides per month. A new law in 2022 was passed for Veteran's that also brings new work for that part of his current job. It

was requested a new job description, supervision information and any other changes in responsibilities be in writing before this is approved.

Wicht was present to give information on a lease for a tractor.
