Terry Wicht, Highway Supt., informed the Commissioners about road conditions with the rainy weather we are currently having.

Andrew Matney, 911 Director, reminded the Board about National Severe Weather Awareness week.

Commissioners Reports:

Commissioner Ahmic reported she met with the Zoning Administrator, the Veteran's Service Officer and some constituents. She worked on the courthouse tree project and received calls about roads.

Commissioner Vrbka reported he attended the Upper Big Blue NRD meeting last week and also received calls about road conditions.

Commissioner Culver reported he participated in the Four Corners Health District briefing, a Blue Valley Community Action meeting, a Seward County only briefing with Four Corners, a Seward/Saline Solid Waste meeting and received calls from the public about various zoning and road conditions.

Commissioner Schmieding reported he has a Visitors Committee meeting this week, received calls about railroad crossings and went with the Building and Grounds Supt. to a local nursery and tentatively chose a courthouse tree.

Commissioner Zabrocki reported he attended a BRIDGES meeting the previous week, held a meeting with the 911 director, participated in the Seward County only briefing with Four Corners, and worked on the courthouse tree project.

The Board discussed Legislative Bill 310 which was in regard to decreasing Inheritance Tax. It was decided that each Commissioner would send their own letter of opposition to our legislative representative.

Moved by Zabrocki and seconded by Vrbka to authorize the Chairman to sign the Surplus Property Disposal Request from the Road Dept. with salvage disposal. Affirmative Vote: Zabrocki, Vrbka, Ahmic, Schmieding, Culver Motion Carried

Moved by Schmieding and seconded by Vrbka to authorize the Chairman to sign the Surplus Property Disposal Request from the Road Dept. with disposal by sale. Affirmative Vote: Schmieding, Vrbka, Ahmic, Zabrocki, Culver Motion Carried

Moved by Zabrocki and seconded by Ahmic to authorize the Chairman to sign the Surplus Property Disposal Request from the Road Dept. with disposal by trade-in. Affirmative Vote: Zabrocki, Ahmic, Vrbka, Schmieding, Culver Motion Carried

The Board then discussed an engineering study for railroads. Wicht stated that the study shows we have redundant signs near a railroad crossing since the railroad is responsible for signage. He stated the Road Dept. is removing the redundant signs. He will send a letter to the railroad indicating their action.

The Commissioners discussed adding an East Seward Road Project to the 1 & 6 year Road Plan. Wicht wanted to know if the Board wanted him to add it to the plan. Zabrocki stated the City of Seward has roughly \$500,000 towards an engineering study for the project. He stated that our County Attorney's opinion is that it is a county road. He suggested if there is Federal money available, to pave it to the homeowner's curb, but not to the highway. Brett Baker, a homeowner living in the area, spoke on the issue. He said there were many incentives between the City and County to work on it and suggested a Commissioner be appointed to a committee.

Moved by Zabrocki and seconded by Ahmic to direct the Highway Supt. to publish a Notice for a Public Hearing regarding an amendment to the 1 & 6 year Road Plan. Affirmative Vote: Zabrocki, Ahmic, Schmieding, Vrbka, Culver Motion Carried
