## **Commissioners Reports:**

Commissioner Zabrocki reported he met with the HR office, participated in interviews for the Zoning Administrator, attended a public transit meeting in regard to driver safety training, a meeting with the Assessor, an employee luncheon, and the Nebraska Public Agency Investment Trust (NPAIT) meeting in Omaha. He also participated in a Nebraska Intergovernmental Risk Management Association (NIRMA) roundtable via Zoom, attended a BRIDGES meeting, a Local Technical Assistance Program (LTAP) meeting, and will go to a meeting in Nebraska City for a Disaster Management Session.

Commissioner Schmieding thanked those involved in the employee luncheons held last week and reported he visited with the County Treasurer. He attended a groundbreaking at Utica of a new subdivision, and noted information about Apace and Region V.

Commissioner Ahmic reported she attended the employee luncheons, completed the American Rescue Plan Act (ARPA) report and noted information about the ARPA obligations for the village of Pleasant Dale, helped submit a grant request for the Lower Platte Weed Management, worked with a constituent who has some noxious weed challenges in his ditch, attended the Local Technical Assistance Program (LTAP) webinar, met with some veterans, attended the Broadband meeting, attended a Water Leaders Assn. planning session, attended to the Zoning Office, responded to various emails, talked to Nebraska Dept. of Transportation (NDOT) representatives, and worked on Community Safety Action Plan (CSAP) presentation.

Commissioner Culver reported he attended interviews for the Zoning Administrator, looked at claims, checked in with various offices and will attend three village board meetings this coming week.

Commissioner Hain reported she met with Commissioner Zabrocki, the Assessor and her Deputy about trying to educate residents about the appraisal process, attended employee luncheons, completed evaluations, sent out information about Community Safety Action Plan (CSAP) grant, worked in Community Projects Fund (CPF), met with Jail Director and Asst. Director, will get cookies for the Correctional staff for Correctional Staff Week, meeting with the Well Being Initiative group this coming week, prepared for the Grant Writer meeting, and checked roads.

Brandy Hafer, Public Transit Director, was present to give information about purchasing cameras in the transit vehicles that can be paid for by a reimbursable grant.

Moved by Hain and seconded by Zabrocki to approve a quote from Safe Fleet for cameras in Public Transit Vehicles in the amount of \$16,218 to be paid initially by the Inheritance Fund and will be applying for a grant which will reimburse the cost of the cameras.

Moved by Hain and seconded by Zabrocki to approve the bid for \$2,848 from Safe Fleet for installation of dash cameras for two fleet vehicles to be paid out of the American Rescue Plan Act (ARPA) Fund.

Hafer then provided a letter received from the Seward School Board in regard to information about Public Transit providing services of transporting students to Seward Public Schools. Hafer stated she had tried to get on the Seward School Board agenda and was not able to. She also stated she has been getting more and more requests for student transportation. Commissioner Ahmic stated she has been asked why the service is not being provided in Milford. It was decided to continue the service now until the end of the school year and revisit the subject at a later date.

Roxanne Knutson, HR Director, was present to give the recommendation of the hiring committee to offer the job of Zoning Administrator to Marissa Pfile.

Moved by Zabrocki and seconded by Culver to approve the appointment of Marissa Pfile as Zoning Administrator with a starting wage of \$25.76 with the wage increase to \$26.56 on July 1 with her starting day to be May 20, 2024.

Jon Regnier, Highway Supt., gave information about two utility permits on the agenda.

Commissioner Ahmic stated she worked with a representative of gWorks to obtain the necessary payoff amount needed to end the contracts of various offices due to going with a different vendor for GIS.

Moved by Zabrocki and seconded by Hain accept the offer from State Farm Insurance in the amount of \$26,670.65 for the loss of a 2023 Chevrolet Equinox and authorize the Chairman to sign documentation of settlement acceptance.
