John Regnier, Highway Supt., and Trever Trebilcock, Asst Highway Supt., were present to update the Commissioners on activities of the Road Dept. Regnier stated that they have a belly dump trailer that is rusting out and not usable. He said he has a truck and pup that is surplus. He has contacted a dealer that would take the trailer and truck and trade for a new belly dump trailer. Regnier also talked about communication from Lancaster County about a bridge that is on the county line that they want to repair and want Seward County to pay for half. There has been no communication about this previously so that we can budget for it. A meeting with Lancaster County is scheduled for December 9, 2024. Regneir said a door to the Milford Road Shop needs repair. They will call on the company who fixed it last for repair. Also discussed were road conditions after the recent rain.

Roxanne Knutson, HR Director, was present to ask the Commissioners to approve a hiring bonus for the Road Dept. positions. They have several positions that have remained vacant for several months.

Moved by Hain and seconded by Culver to approve a Tier 1 hiring bonus for the motor grader operator and heavy-duty equipment positions of the Road Dept. which is \$500 at 90 days of employment, \$500 at 6 months of employment and \$1,000 at 1 year of employment.

Commissioners Reports:

Commissioner Zabrocki reported he attended a City of Seward Planning Commission meeting and a Seward County Planning Commission meeting, a Broadband Task Force Meeting, communicated with the Building & Grounds Supt. about the grounds by the West Wing, and communicated with the city officials about the TIF Report.

Commissioner Schmieding reported he was unable to go to the Visitors Meeting this past week. He commended the Extension Office for helping with an event for the Fairgrounds. He participated in a Zoom meeting with Region 5 and Apace.

Commissioner Ahmic reported she attended a Broadband Taskforce Meeting, participated in a Community Safety Action Plan (CSAP) review meeting, a Seward County Chamber & Development Partnership (SCCDP) meeting, attended the Seward County Planning Commission and dealt with Region V and Apace items. She also noted that Seward County was awarded the Safe Street and Road Grant in the amount of \$400,000 to help with a feasibility study for a bypass corridor near Milford.

Commissioner Culver reported he had a Seward/Saline Solid Waste meeting and visited with two constituents about roads.

Commissioner Hain reported she helped with the Caregivers Retreat planned by the Aging Services Dept., participated in the Community Safety Action Plan (CSAP) review meeting, met with the HR Director, completed two employee evaluations and gave information about the buildings at the main road shop.

The contract for Region 5/Apace that is on the agenda was briefly discussed. Commissioner Schmieding participated in a meeting yesterday with the Region 5/Apace organization and voted yes on the contracts and so the need to vote on the contract was not needed. The issue of Region 5/Apace not updating their bylaws and other paperwork since Apace changed their name was discussed.

Moved by Culver and seconded by Zabrocki to not authorize the Chairman to sign Region 5 and Apace contracts.
