A regular meeting of the Seward County Board of Commissioners was convened in open and public session at 8:30 a.m. on September 6, 2022 in the Commissioner's room at the Seward County Courthouse. Notice of the meeting was posted on the Courthouse bulletin board and on the Commissioner's Room door. The agenda for all meetings is kept continually current and is available for public inspection at the County Clerk's Office during normal business hours. The agenda is held open until one business day prior to the meeting for appearance before the Board. The Board of Commissioners has the right to modify the agenda to include items of an emergency nature only at such public meeting.

The Seward County Board of Commissioners convened on September 6, 2022 at 8:30 a.m.

The Chairperson noted that the public meeting information is posted as required by law and available for public distribution if requested.

The Pledge of Allegiance was recited.

Jonathan Jank, Executive Director of Seward County Chamber & Development Partnership (SCCDP), and Harrison Helmer, Executive Director of BRIDGES, updated the Commissioners on activities of their organizations. Donna Hendrickson was also in attendance to introduce herself as a new member of the SCCDP staff.

Those officials updating the Commissioners on activities of their offices were Ann Dobesh, Marilyn Hladky and Sherry Schweitzer.

Commissioners Reports:

Commissioner Ahmic reported she received a call about a nuisance property, talked to a UNL Representative and helped Assessor with a letter of communication about unreported property.

Commissioner Vrbka said he received complaints about [pivot] water over the road.

Culver reported he had contact with the Assessor, went to a Road Dept. Training session, and received phone calls.

Commissioner Schmieding reported he will have an Extension Board Meeting this week.

Commissioner Zabrocki reported he viewed a NIRMA round table event via Zoom and went to a Highway Dept. meeting.

The Commissioners discussed inventories and each took an office inventory, to which they are liaison, to check.

Barb Armstead, Deputy County Attorney, updated the Commissioners on the National Opioid Settlement. She noted that she received an email noting the amount of the settlement for Seward County which was \$4,400.00.

The Commissioners discussed the missile base silo project with UNL. Ahmic stated they are wanting to have an additional contractor, Bockmann Inc, assist with the drying out of the area they are wanting to occupy in order to have the stairs replaced.

Moved by Vrbka and seconded by Ahmic to approve Bockmann Inc. to help with the mud and water removal starting Sept 6, 2022.

Commissioner Zabrocki led discussion that he had with our liability insurance carrier, namely Nebraska Intergovernmental Risk Management Agency (NIRMA) concerning the Missile Base Project. They suggested acquiring certificates of insurance, a hold harmless agreement and a memo of understanding. Zabrocki said he talked to the County Attorney and she stated she could draft a hold harmless agreement if she is given more information. Drafting a memo of understanding will be difficult in order to make it so that it encompasses the whole project. The Commissioners stated ensuring the County is protected, through all the various steps of the project is the ultimate goal.

Marci Fehlhafer, Executive Director of CASA, was present to discuss leasing part of the 3rd floor of the Courthouse.

Moved by Vrbka and seconded by Ahmic to authorize the Chairman to sign the lease agreement for office space with CASA.

Discussion was held about removing the carpet in the leased area of the courthouse. CASA will hire a company to come and remove the carpet if it is in their budget.

Moved by Schmieding and seconded by Ahmic to accept the County Clerk Fee Report for August 2022 in the amount of \$46,661.87.

Moved by Vrbka and seconded by Zabrocki to accept the Sheriff Fee and Mileage Reports for August 2022 in the amount of \$1,527.00 and \$1,123.72 respectively. Affirmative Vote: Vrbka, Zabrocki, Ahmic, Schmieding, Culver Motion Carried

The Commissioners recessed at 9:43 a.m. The Commissioners re-convened at 9:45 a.m.

Ann Dobesh, Extension Agent, was present to discuss the offer from the insurance for the Extension Office van that was damaged in the June hailstorm. She stated the vehicle has 82,000 miles on it and has some rust.

Moved by Ahmic and seconded by Schmieding to approve accepting the offer from the county insurance carrier for the Extension Office Van for a total loss of the vehicle for \$10,112.00 and place the proceeds into the Extension Office Sinking Fund.

The Commissioners briefly discussed infrastructure related grants.

The Commissioners briefly discussed some county projects for which American Rescue Plan Act (ARPA) funds may be used.

The Commissioners recessed at 9:52 a.m. The Commissioners re-convened at 10:00 a.m.

Spencer Conradt, 911 Director, was present to give information about installing an emergency exit door near his office. Currently, there is only one way to exit the 911 Center and it is to an area that contains quite a lot of electrical utilities. Installing this door would make another exit available for the center. Chairman Culver suggested they contact the State Fire Marshall to ensure the installation of this door is approved by their standards.

The Commissioners recessed at 10:04 a.m. The Commissioners re-convened at 10:15 a.m.

Sheriff Mike Vance was present to discuss the purchase of the Homeland Security Investigations Criminal Interdiction Task Force -West building and property. He was at the Commissioners meeting last week when he was asked to find answers to two questions. He furnished a letter from the Dept. of Treasury and gave answers to those questions about purchasing it.

- 1. If the county decides to sell the building, any money above the purchase price would not have to go to the Drug Fund.
- 2. If the building is retained, it would have to be used by a government entity. Deputy Attorney Armstead had further questions about the information Vance received and will contact the person who informed Vance to get something in writing.

The appraisal of the building was discussed as well as the price of the building.

Moved by Vrbka to purchase the Homeland Security Investigations Criminal Interdiction Task Force-West building and property.

Commissioner Vrbka withdrew his motion.

Commissioner Ahmic stated she felt the issue needed to be tabled since there are many questions about it to which Commissioners Schmieding and Culver agreed. Schmieding asked if a counter offer has been offered.

The Commissioners asked Armstead to clarify any issues she has after receiving information about selling the building if we no longer have a use for it.

On the livestreaming item on the agenda, Armstead said she has had some requests for it. Culver stated he feels that it would possibly disrupt the meeting.

Raegan Hain, a member of the public, stated she would like to see meetings live streamed. Schmieding says he wants to be transparent, but with our website, everyone can follow the agenda and agrees, it can be disruptive. Zabrocki said he watched another county's meeting and would be open to trying it. Ahmic said she can see both sides but would discourage active participation. Vrbka wondered if the technology would be troublesome. Derek Bargmann, Seward City Clerk, gave information on how the City of Seward does it. He stated they make a video and upload it to YouTube. Sheriff Vance said he would not be comfortable with some of his information he gives at meetings being on YouTube.

Moved by Schmieding and seconded by Zabrocki to not have the meetings live streamed until more information is available.
